It is with much concern that we are writing to you regarding the traffic flow past our units. As it is just the first week of the limited entrance and exit, we are very concerned as to what it will be like in the coming months, as the majority of the traffic flowing past the units is travelling well in excess of the 20KPH speed limit. It appears to be mainly the traffic from phases 2 and 3 that DO NOT STOP AT THE STOP STREET, CUT THE CORNER INTO OUR ROAD, AND EXCELLERATE PAST OUR UNITS, as if they were on Kyalami circuit.

Already this week, there have been two near misses with traffic turning into our road, at great speed, as we reverse out of our driveways. We realise that not all of the traffic are residents, but that some are trade persons and visitors. How on earth are we going to make people understand that they have to curb their speed, and drive with great caution, so as to avoid a really nasty accident.

We understand that there is no alternative, at this stage, regarding the flow of traffic in the village, BUT surely something can be done to make people more aware of the dangers of speeding and NOT adhering to the stop signs.
