Dear Residents,

REVISED LEVEL 1 LOCKDOWN REGULATIONS.

After the president's address last night and the move to Lockdown Level 1, per section 77 of the Regulation, protocols are adjusted as follows:

VILLAGE ACCESS

- Screening and Access Control remain in place for all non-residence entering the village.
- Wearing of masks remain compulsory for anyone entering the village.
- Contractors passes will be issued to every individual entering the village.

VISITORS

- Controlled visitations by members of the public is allowed and each resident is requested as a courtesy to please notify security prior to visitors arriving. Residents are also expected to keep record of their visitors for tracing purposes should the need arise.

CONTRACTORS - Due to finalisation of protocols access will be allowed from Monday 8 March 2021

- It is recommended that non-essential internal work be limited as far as possible to avoid unnecessary contact with contractors.
- All scheduled work must be shared with Village Management prior to work commencing to arrange for Contractor Protocols to be shared with contractors and access approved.
- Emergency and essential repairs will continue under the same guidelines currently in place.
- Contractors must avoid loitering in common areas within the village in any way.
- Residents will be required to maintain and manage safe distancing between themselves and workers at all times.
- Work areas must be sanitized during and on completion of work.

BISTRO and LIFESTYLE CENTRE

- Wednesday night social dinner will re-start on Wednesday 10 March 2021. This means that the Dinner@Home take away option for Wednesday dinners will fall away.
- Take-away and freezer meal option will remain in place for all lunch menu's
- Social distancing to be followed at all times.
- Sanitizing before and after activities and interest groups will remain in place.
- Residents visiting the Lifestyle Centre on a social basis are required to sanitise upon arrival.
- The gym / exercise equipment will be available for use. Space only allows for limited residents at a time and sanitizing after use is compulsory.
- All protocols currently in place for groups and activities remain in place.
- Groups must be limited and will be dictated by the size of the venue and to a maximum of 50% of the allowed capacity.
- Open Air Functions and Events are encouraged,
- The social calendar will be re-introduced in line with what can be allowed safely and within Level 1 regulations.

DOMESTIC / GARDEN SERVICES

- Evergreen domestic and garden services can be booked and normal schedules can be followed.
- Private domestic workers and gardeners are allowed to resume work in the village.
- Daily screening and temperature checks must be adhered to upon entry.
- Any new domestics or gardeners must be registered before starting work in the village.

GENERAL

- We still ask that residents who want to see a nurse, call for the nurse to come to your home rather than going to Frail care.
