9. **GENERAL - QUESTIONS**

Question 1- Merle Els

Do we have insurance cover and what does it cover?

Answer - Question 1

GR confirmed that we do have insurance on the buildings, risk, and public liability all in place. The insurance is taken out on the entire business rather than individual villages to ensure the costs are kept as low as possible while having adequate cover in place. GR reminded residents that they have to ensure all their home content privately.

Question 2 – Brian Quinn

Noted that documents distributed indicated an increase of around 4% but reference was made to 5% and requested clarification.

GR indicated that the minutes for last year reflected the budget and increased for FY2024-2025 (FY25) and this year's pack included the increase for FY2025-2026 (FY26).

Question 3- Merle Els

Will special levies be implemented to cover any losses?

Answer - Question 3

GR confirmed that no special levies are charged to residents as per the LRA and that the property owner, Evergreen Property Investment absorbs any losses. It does however not give us the freedom to overspend and run losses.

Gail Rohn thanked Management for the change in caterers and encouraged residents to support the bistro.

Question 4 – Amina Abader

Is it possible to provide Halaal meals in the Bistro?

GR confirmed that It can be arranged but will not be possible for the contracted caterers to provide these meals as they do use non-Halaal food items in their kitchens. Pricing and options can however be requested through Amanda or Riaan.
