In addition, there has also been reference to the fact the artificial grass is not allowed on the Estate, other than in enclosed courtyards where ordinarily, these areas would be paved.

On the issue of the artificial grass, as LM is an Eco Estate it was a concern of the Board who thought it prudent to seek comment from Holland and Associates, the environmental consultants who prepared a submission on behalf of the LMHOA in response to the Doug Jefferies Basic Assessment Report, which the office has circulated to members.

In respect of the roofing matter, minutes of Board meetings are listed below which are self explanatory.

It is correct in stating the board voted unanimously to "allow an alternative roofing material be allowed in place of the bitumen shingles...." However please see the extracts from subsequent board meetings.
