1	OK thanked KW for distributing previous meeting minutes.	
2	Extractor fan – ground floor to be done next week. Second floor next month. SW asked DD to check her extractor fan.	DD
3	Security and rise of crime to be highlighted to staff and residents. Staff have been harassed en-route to work at Cemetery. MO to make contact with a senior SAP Through SPF- Geoff Fox.	МО
4	Report on open meeting on health issues. OK thanked HT. DD has sent the presentation by Elise to all residents. Health care explained they have approval from Discovery and are negotiating with other medical aids as a registered sub-acute and step-down facility. HT stressed that residents need to understand their own individual medical aid and cover plan. Residents without medical aid will be charged private rates. Refer to Elize circular. Rescom discussions on progress re "clinic" services. In the interim the health care centre will attend to emergencies etc. There is currently a village nurse.	HT/AB

6	SW queried number of arrears levies and outstanding levies on empty units. DD to provide latest residents stats. HT requested that Head Office contribution to unpaid levies be itemised at the top of the income statement.	DD
7	Bistro HT/DD feedback Negotiations with other catering suppliers are in progress. EF has noted that there has been a marked improvement in the supply of goods and services. EF complimented the Bistro service. SW enquired how the village is reimbursed for meals supplied to frail care. Evergreen village get an allocation from meals serve to frail care residents. It was requested that the frozen meals and soup be advertised by the Bistro. The Bistro is to check that their Bulletin TV is functional. Residents' monthly braai is scheduled for 25 June at 6 pm. 	EF requested that the sprinklers be fixed at his home. 4.40 is the time for EF – to follow up with maintenance, Aashiq The sprinklers are left to run during the rain. The harvested water which is stored underground is used for the sprinklers.	
12	EF has a damp problem which DD is to address. Outside West wall and garage wall is still damp. Inside damp is repaired.	DD
13	Recycling must be made easy for residents for their buy-in. Recycling of plastic and wet waste. Wet waste to be kept separate. Recyclables separate and cleaned. Balance separated for landfill. MO/EK to revisit the system. Michael is our contractor who comes twice a week to collect recyclables only. Disinfection of bin area. DD done.	MO/EK

the LRA that gives the property owners the right to delegate insurances to the
 residents. As I have said in my e.mail, it is absolutely unheard of for property
owners to charge tenants/residents for this insurance which is definitely the
liability of property owners. The 0% increase stated by Garry is nothing
 whatsoever to do with insurances.
