Travel – Fuel R6638.00 what is this cost for? Year-to-date figure
 Maintenance manager – collects maintenance supplies from various suppliers
 Travel for choir mistress

• SLA – Security R506000.00 how many salaries does this amount include per month and is there a management fee hidden in that amount?

Year-to-date figure

Management fee is not hidden – it what we pay every month

 A concern over the lack of consistency in motor vehicle licence monitoring and other ongoing issues in this regard has prompted the query.

### **Garden Maintenance**

- SLA Garden Maintenance R202152.00 does this include a monthly "management fee" if so how much is it? It is the Management fee
- Does the village pay the common area gardeners or are they on Whitecliffs payroll? No. Private contractors pay their own staff

## **Catering Expenses:**

Catering Consumables R14206.00 what is this cost for?
 This is the Year-to-date figure
 It is for the gas to service the kitchen stove

## **Queries on the September Draft:**

Salaries – Refurbishing Team R81900.00– should this not be Head Office or EPI?

Why is it a village expense when we do not own the properties involved – EPI do?

Year-to-date Head office recovery allocated under Refurbishing team

Medical response – R65000.00 and Management Fees R65000.00 both Telecare?

Year-to-date fee

Misread – it was the header and the allocation which looked like a duplication

Insurance Costs raise its head again.

This time we refer to the letter from GR to Annie and Frank House 93 i.r.o the repairs to their house, wherein he states quite clearly that Evergreen Property Investments Own all the buildings and therefore they must pay.

We suggest that this cost is for EPI not Muizenberg Village levies to residents.

This is part of residents Life Right Agreements
